

2. WHEREAS, as per the decision of ERC in its 154 meeting held on 22-23 April 2013, recognition order was issued to **Madhavan Memorial College of Education, Plot No.-1652/1653/1651, Street No.- Karmatad, Vill- Shividham, Po-Maniyarpur, Tehsil/Taluka-Bounsi, Town/Dist. -Banka, State-Bihar-813104** for conducting **B.Ed.
