College, Plot No. 62, 63, 64, 65, Street No. 1, Village – Lakrakhanda, P.O. – Bokaro, Town/City – Bokaro Steel City, Tehsil/Taluka – Chas, Dist. – Bokaro, Jharkhand - 827010 (Code No. ERCAPP708) for B.Ed. Course online on 29.09.2010 for two year duration and hard copy received by Eastern Regional Committee of NCTE on 11.10.2010.

- 2. **AND WHEREAS**, as per decision of  $141^{st}$  ERC Meeting held on  $21^{st}$   $22^{nd}$  August 2012, recognition order was issued vide no. ERC/7-141.6.39/NCTE/B.Ed./2012/13728 dated 28/08/2012 with an intake 100 from the academic session 2012-2013 to the institution, followed by revised order issued on 30/05/2015 as per Regulation, 2014.
- 3. **AND WHEREAS**, as per decision of 244<sup>th</sup> ERC Meeting held on 8<sup>th</sup> 9<sup>th</sup> October 2017, recognition granted to B.Ed. course was withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session vide Order No. ER-244.17.6/ERCAPP708/B.Ed./ 2017/54737 dated 18.10.2017.
- 4. **AND WHEREAS**, the institution preferred an appeal to NCTE HQs. and the Appellate Authority vide Order No. 89-704/E-45175/ 2017-Appeal/22nd Mtg.-2017/18th, 20th & 21st Dec., 2017/63134 dated 13.02.2018 remanded back the case to ERC with a direction to consider the reply dated 11.11.2014, to be sent to them by the appellant, and take further action as per the NCTE Regulations, 2014. The appellant was directed to forward to the ERC their reply dated 26.12.2014 with all its enclosures within 15 days of receipt of the orders on the appeal. In the meanwhile, the order of the withdrawal shall be kept in abeyance.
- 5. **AND WHEREAS**, the ERC in its 252<sup>nd</sup> Meeting (Part-3) held on 28<sup>th</sup> February to 3<sup>rd</sup> March 2018, reviewed the matter in accordance with the appeal order and observed that all required documents, as submitted by the institution to the Appellate Authority, have been received.

In view of the above, the Committee decided as under:

Recognition for B.Ed. Course is allowed to continue.

- 2. AND WHEREAS, on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit submitted and the report received from VT and videography, and the certificates received from the affiliating body, the Committee is satisfied that the applicant fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, financial resources, etc., for running the programme.
- 3. AND WHEREAS, as per the decision of 141<sup>st</sup> ERC Meeting held on 21<sup>st</sup>- 22<sup>nd</sup> August 2012, formal recognition order was issued vide No. ERC/7-141.6.39/NCTE/B.Ed./2012/13728 dated 28.08.2012 for conducting B.Ed. course with an intake of 100 (One hundred) from the academic session 2012-13 to the institution.
- 4. A Public Interest Litigation vide W.P. (PIL) No. 327 of 2011 has been filed by Shiv Shankar Munda Vs Chairperson NCTE & Ors in the Hon'ble High Court of Jharkhand at Ranchi. As per direction of the Hon'ble High Court of Jharkhand, the said institution was inspected by the NCTE Hqrs., New Delhi under section 13 of the NCTE Act 1993 and Rule 8 of NCTE Rules.

The ERC in its 176th meeting held on 9th October, 2014 considered the matter and as decided, a Notice dated 11.11.2014 was issued to the institution on the following grounds:

(i) Sh. Ram Chandra Roy appointed lecturer in English has submitted his resignation on 16.09.2014.

(ii) The institution is required to appoint a Lecturer in English Method as per NCTE Norms and submit a fresh faculty list duly approved by Registrar of the concerned University adding the name of newly appointed Lecturer.

Reply in response to ERC's Notice dated 11.11.2014 has not been received till date and the institution is still deficient on the above grounds.

In view of the above, the Committee decided as under:

The Committee is of the opinion that recognition granted to **B.Ed.** course of the application bearing Code No. **ERCAPP708** is **withdrawn** under section 17(1) of NCTE Act, 1993 from the **next academic session**.
